RE: POSITION OF THE ATEBUBU TRADITIONAL COUNCIL ON ANNUAL CATTLE MOVEMENT AND KEEPING WITHIN THE ATEBUBU TRADITIONAL AREA

The Council writes to formally communicate its considered and firm position regarding the **annual movement, grazing, and keeping of cattle within the Atebubu Traditional Area, particularly by Fulani herdsmen.**


The Atebubu Traditional Council under the leadership of HRM Ohempon Dr. Yeboah Asiamah – Atebubumanhene and President of the Council wishes to state unequivocally that **it does not accept nor approve the annual movement, grazing, or permanent keeping of cattle within the traditional area**, as this practice has over the years caused numerous and persistent problems for farmers and residents. These problems include the destruction of food crops, encroachment upon farmlands, loss of livelihoods, frequent disputes between farmers and herdsmen, and rising threats to peace, security, and social harmony within the communities.

The Council has received repeated and widespread complaints from farmers across the traditional area whose farms have been destroyed, resulting in significant economic hardship and growing tensions. After careful deliberation, the Council has concluded that the continued annual influx and presence of cattle pose a serious challenge to agricultural productivity, food security, and sustainable development in the Atebubu Traditional Area.

In light of the above, the Atebubu Traditional Council respectfully calls on the Atebubu Amantin Municipal Assembly to take due notice of this position and to collaborate with the Council, relevant security agencies, and other stakeholders to put in place and enforce appropriate measures to prevent the annual cattle movement and unauthorized grazing within the traditional area, in order to protect farmlands, safeguard livelihoods, and maintain peace and order.

The Council trusts in your usual cooperation and commitment to the welfare and security of the people of Atebubu.
